

# SOCIETY AND MEDICINE IN CHINA: A SPECIAL CASE STUDY

**Abstract:** In China, there is a special case that a man has been suffering from lots of in his life. But accompanying his suffering, there are lots of other people are live in un-normal life. The sufferings to the man has been causing un-peace and un-harmonious society In all his life time, his brain thinking has been being communicated to others all the time. Even though he is a Communism pursuer. But the most important suffering is that he was expelled from Cancer Institute, graduate school of Chinese Academy of Medical Sciences/Peking Union Medical College(CAMS/PUMC) as a postgraduate student just before graduating and just before getting his graduate certificates in November, 1990 without any right lawful support by the CAMS&PUMC. The most heavy suffering is that his brain thinking has been being communicated to others all the time. In order to take care the special social sufferings, the roots of the sufferings of the man should be cleared. So that the suffered society can be cured. It is caused by social competitions. Up to now, China has not pay attention to it. The treatment of the special social sufferings may need international cooperation. In order to promote better and harmonious society and promote better public health, the special case of problem must promote and enhance the reformation and correcting its policy of public health in China. The reformation and correction can be referenced by other countries.

## INTRODUCTION

China is a communism country, an Asian big country. The communism country should be much too fairer in the society. But the communism country, China, is displaying unfairness, the problems of public administration. The special example of case is the special sufferings of a man. Though he is a pursuer of Communism. The communism country China is still not reforming and correcting its rights to fair the innocent man. So the big problems of public health have been arousing in China. By accompanying his suffering, there are lots of other people are live in un-normal life. The sufferings to the man has been causing un-peace and un-harmonious society. In all his life time, his brain thinking has been being communicated to others all the time. Even though he is a Communism pursuer. In order to take care the special social sufferings, the roots of the sufferings of the man should be cleared as soon as possible. So that the suffered society can be cured. It is caused by social competitions. Up to now, China has not pay attention to it. There is not any research and reports about these things. Which is identified through a MEDLINE search of the English-language literature on “Society and Medicine in China, A Special Case Study” and (or) the key words of this paper.

As a special case study, in this paper, the author reports the facts of sufferings of a man. So the author points out the related social problems of public health by causing the suffered man. The aim of the paper is to clear the facts, promote and enhance the public health in China. The utmost objectives are

speeding the recovery of the social sufferings of public health in the world.

#### EVIDENCES

He is living with no social security in People's Republic of China. He is a Chinese and 46 years old. He has been suffering from lots of unfairness, including education, study, working and job, etc. Please look the following evidences.

#### The present sufferings

As he is a doctor, he is striving to cure the heavily sick workers and other patients in China. And his treated patients have been recovering very well. But he is fined and heavily wrongly interfused by the medical insurance center of Nanyang city, Henan province, China when he treats the patients. The medical insurance center took these actions without medical science supported. And his wage is fined to much too lower than the average city wage of workers. So his life is difficulty. His doctor job has been demoted. Which is preventing him from curing the patients well. Maybe the other medical insurance centers in China are also heavily wrongly interfusing the medical sciences and the rights of doctors. But his doctor rights are much too heavily interfused.

He comes from China, a Communism country. He has worked 25 years as a doctor and a Communism pursuer. According to Chinese Social Security policy, he should have the rights to enjoy China's preliminary social security system. Which includes urban basic pension insurance, urban basic medical insurance, work injury insurance, unemployment insurance and maternity insurance. All the insurances are paid by the working unit. And about 8% the insurance fee of urban basic pension insurance is paid by the worker's wage before the worker get his left wage. Among them, the urban basic pension insurance is the most important one.

But up to now, he has not enjoyed any these China's preliminary social security system, apart from 2 years or so the urban basic medical insurance. All his personal urban basic pension insurance was paid. But the urban basic pension insurance money payment was postponed more than one year by Nanshi hospital, a hospital under administration of Henan Province branch (oilfield) corporation (or Henan Province Petroleum Administration), China Petrochemical corporation, the latest of his former work unit. Even worse is that the right of his urban basic pension insurance official certificate is not controlled by him up to now. For the Nanshi hospital, by pretending to hand his urban basic pension insurance money payment process, has been grabbing his urban basic pension insurance official certificate but doing nothing for his urban basic pension insurance money payment process. His urban basic

pension insurance money has been nearly being lost. To say nothing his other preliminary social security items. He has been trying more than 2 years to get his urban basic pension insurance official certificate transferred to him. But no results are got. While the Chinese official law for urban basic pension insurance money transferring process between the provinces in China is only 45 days.<sup>[1]</sup> But, the urban basic pension insurance money transferring process in the Henan province of China is only 15 days.<sup>[2]</sup> It is shame for the related officials that his urban basic pension insurance money transferring process has been being spent more than 15 times the 45 days official limited. Even more shameful is that his urban basic pension insurance money transferring is only in a provincial city, the Nanyang city, Henan province, P, R, China.

Besides the Nanshi hospital, the Social Security office of Henan Province Petroleum Administration of China Petrochemical corporation, located within Nanyang city, Henan province and the Henan province Social Security administration center for enterprises, located within Zhengzhou are also taking postponed hands. He has been applying for help to Chinese media, government helping center, and Nanyang city government, etc.. But no reply at all!

But the transferring of urban basic pension insurance money of other ordinary workers in China are easy.

#### The past sufferings

He was expelled from Cancer Institute, graduate school of Chinese Academy of Medical Sciences/Peking Union Medical College(CAMS&PUMC) as a postgraduate student just before graduating and just before getting his graduate certificates in November, 1990 without any right lawful support by the CAMS&PUMC. There was not any official notice to expel him from the graduate school. Only a few people unlawfully told him orally that he should get out the CAMS&PUMC in November, 1990. While he had finished and passed all his graduate courses, graduate training plan and researches in graduate school of CAMS&PUMC. In April, 1999 to April, 2000, in order to seek fair treatment, he took the issue of his being expelled from graduate school of CAMS&PUMC to the Chaoyang district court of Beijing. While the Chaoyang district court of Beijing judged against the law and facts, did not fair him and did not give him the graduate certificates and compensations. The Beijing Chaoyang district people's court for his issue recording materials number is No.6900 in year 1999 civil judicial procedure.

In December, 1996, he was hit by the planned unlawful trouble makers and caused him suffering from long time nerve and bio-psycho-social medical

damage and short time face damage. He took this issue to the court of Xinye county, Henan province, China, by himself with his own wage savings to seek fair judgment. But the court of Xinye county, Henan province, China, judged against the law and did not fair him. The trouble makers had not been fully punished and the official final notice by the Public Police for investigating the case had not reached when he took the issue to the court of Xinye county, Henan province, China. According to the Chinese law, he should have the right to seek compensation by court civil judicial procedure when he did not receive the official notice of the trouble makers' identified information. But the court of Xinye county, Henan province, China judged against this law. The Xinye county people's court for his issue recording materials number is No.102 in year 1999 civil judicial procedure.

According to the Chinese laws at this time his sufferings was belong to damages at the working time and could receive government compensations. But not any government compensations has he received up to now.

In October, 1997, he was damaged by the rivals to suffering from intestine bleedings. He lost lot of blood.

In April, 2005, he was refused to be enrolled into Zhejiang University as a postgraduate student majoring in emergency medicine for high level doctor education.

In December, 2007, he again was hit by the planned unlawful trouble makers and caused him suffering from long time nerve and bio-psycho-social medical damage and short time face and arms damages at Department of emergency medicine of Xinye county people's hospital, Henan province, China. While the related government departments and hospital officials did not do fair treatment to him.

In September, 2008, he was taken in when he was changed into high level and high wage payment hospital, Nanshi hospital, a hospital under administration of Henan Province branch (oilfield) corporation (or Henan Province Petroleum Administration), China Petrochemical corporation, also a worker's hospital of CHINA RG PETRO-MACHINERY (GROUP) CO. LTD and an affiliated hospital of Henan University, China. He worked as a hospital medical sciences and education strategy maker. And the doctor majoring was refused to let him do. He worked and researched wholeheartedly and important medical sciences of strategies and ideas were invented. The important medical sciences papers were done. After the Nanshi hospital and others stolen his medical science ideas and strategies. He was expelled from the Nanshi

hospital. And he has lost his former stable job and life. Several months, he had been no job to do and life had been being no support. Now, he is still working as a unstable worker in a low payment hospital as a doctor. He had got divorced.

He took the labor-dispute issue with Nanshi hospital to Nanyang city labor-dispute arbitration commission, Henan province, China for arbitration in later year of 2008. The Nanyang city labor-dispute arbitration commission arbitrated shamefully against the law and did not fair him. According to the Labor Contract Law of the People's Republic of China, "In the event that no written labor contract is concluded at the time when a labor relationship is established, such a contract shall be concluded within one month as of the date when the employing unit employs a worker". Or the employing unit should pay two times wage to the worker after more than one month the employing unit had not concluded a written labor contract. He had worked more than 4 months at Nanshi hospital with no written labor contract. But only pay him less than normal wage. All which the Nanshi hospital aimed to steal his medical science ideas and strategies. The Nanyang city labor-dispute arbitration commission did not arbitrate fairly to him. But ridiculously arbitrated nothing to him. The Nanyang city labor-dispute arbitration commission for this issue recording material number is No. 19 in the year of 2009.

In all his life time, his brain thinking has been being communicated to others all the time as a talent doctor and man. Which is the much too rare in China.

In China, no fair pursuit place or government office works to help him.

By the whole evidences, he can say that he is living with no social security in People's Republic of China and he is the Chinese whose human-rights are the most heavily encroached on!

#### **THE INFLUENCES OF THE SPECIAL CASE**

It is said that the sufferings of the man are known to all. It is said that near all the people think that causing the sufferings is the shameful doing. It is said that creating the sufferings to the man has been causing un-peace and un-harmonious society.

The man, the sufferer has been suffering from bio-psycho-social medical damage. He has been suffering from environmental damage. And He also has been suffering from un-harmony family life and un-harmony relatives.

#### **THE REASONS AND RESULTS OF SUFFERINGS OF THE MAN AND SOCIETY**

##### **The reasons and results of sufferings of the man**

It is said that the suffered man is talent, hard working

and no shortcomings. His family and root are specially paid attention to by the world. He grew up from countryside. By himself, he attended the enrollment exam of postgraduate student and was enrolled as a top student into graduate school of Chinese Academy of Medical Sciences/Peking Union Medical College (CAMS/PUMC) in 1988 in Beijing. As a innocent big boy coming from countryside, he study well. Which aroused the class struggles among the upper classes inside and outside China. They were afraid of the innocent big boy growing big and big in capital Beijing from the highest medical institute. They were afraid of the innocent big boy may have big power of medical science knowledge which can influence their position power. So they expelled him from the CAMS&PUMC in the end of 1990. But before expelling, they incited the '6.4 Movement' in 1989, aiming at turning and hungering him into fool. But in vain.

So his brain thinking has been being communicated to others all the time by modern technology to control and scan what he does. After he was expelled him from the CAMS&PUMC in the end of 1990. He has been suffering a lot. Which the main sufferings are written at the front pages.

#### **The reasons and results of the sufferings of the society**

When the man studied in CAMS&PUMC at Beijing, the society competition by the upper classes inside and outside China have incited the '6.4 Movement' in 1989. We all know that '6.4 Movement' had caused much too heavily society sufferings to the society of China. They can not be fully written in this single paper.

The further important things are the society sufferings afterward. Where the man goes to the local society will live and work un-normal, caused by the upper classes inside and outside China. Because the upper classes inside and outside China are still afraid of his big power of medical science knowledge. Even through they have been communicating his brain thinking to others all the time.
